Title of Work Being Registered. This is the title of the specific work you want to register. It is the main title by which the work is known. The work to be registered could be one work, a collection of works (such as an album or anthology), or an individual contribution appearing in a larger work (such as one song from an album or one short story from an anthology).

For example, if your name is common, you may want to include portions of your title. If you are searching by title, and the work has both a title and a sub-title you should start by searching for the title only and see if your search produces a result. Then add terms from the sub-title to your search.
